- This form must be completed by the broker when they conduct face-to-face interviews only
- For foreign documentation, where the documents are not written in English, an English translation prepared by an accredited translator must also be provided
- Broker must ensure all copies of identification documents provided are clear and legible.
- All copies of identification are required to be imagined in full colour and high definition.
- Broker must submit copies of original documents along with this completed and signed form

- Special provisions may also be applied to Aboriginal persons or Torres Strait Islander residents in an Isolated Area

- Minimum requirements are:

Category 1: Passport and driver's licence in full colour and high definition
